Privacy Policy (For NCSS)

Our Commitment to Privacy

The Types of Information We Collect

How We Collect Personal Data

- 3. We may collect personal data for the purposes set out in paragraph 4 below and in the following (non-exhaustive) manner:
 - When you submit the registration form electronically to us;
 - When you interact with Community Chest and/or First Wave the appointed event organiser for Community Chest Heartstrings Walk 2025, for example, via emails and telephone calls;
 - When you request that we contact you, or be included in an email and/or other mailing list;
 - When you submit your personal data to us for purposes and reasons which shall be specified
 and highlighted to you in any additional and/or ancillary document/request to be provided by
 you for the purposes of such data collection/submission.

Why We Collect Personal Data

4. We collect and use the personal data for the purpose of the health declaration for you to be deemed medically and physically fit to participate in the event, and to send you updates on the latest news on Community Chest Heartstrings Walk 2025 for which you have provided consent.

Who We Disclose Personal Data

5. We may disclose personal data to other third parties where necessary for the purposes listed or otherwise required by law. These third parties include government agencies or third-party service providers appointed by Metaphor Creations Pte Ltd for the event.

We take reasonable steps to ensure that these organisations are bound by confidentiality and privacy obligations when handling your personal information.

Consent

6.
