

“ROKU NORYO - MOFT” LUCKY DRAW

TERMS AND CONDITIONS

1. The following terms and conditions shall govern the Roku Noryo - MOFT Lucky Draw (“**Lucky Draw**”) and by entering into this Lucky Draw, You agree to be bound by these Terms and Conditions.
2. Information on how to enter the Lucky Draw and the prizes to be won, form part of these Terms and Conditions.
3. The Promoter is Beam Suntory Asia Pte Ltd having its place of business at 128 Beach Road, #13-03/04 Guoco Midtown, Singapore 189773 (“**Promoter**”).
4. Entry is only open to Singaporean residents, Permanent Residents of Singapore with a valid NRIC or Expats with a valid FIN aged 18 years and over (“**Participants**”).
5. Employees (and their immediate families) of the Promoter, affiliates, agencies and third-parties associated with this Lucky Draw are ineligible to participate in the Lucky Draw. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
6. The Lucky Draw will be conducted on <https://srx.to/rokunoryu> (“**Lucky Draw Website**”) commences on 14/05/2026 at 12:01 am SGT and closes at 11:59 pm SGT on 31/07/2026 (“**Lucky Draw Period**”).
7. To participate in the Lucky Draw, Participants shall complete the following steps:
 - Purchase a bottle of Roku Noryo Tea Edition Gin from the participating outlets only like Fairprice, Cold Storage, Donki in Singapore. One winner each will be selected from each of these participating outlets resulting to three total winners.
 - Once the bottle of Roku Noryo Tea Edition Gin is purchased, Participants can scan, using their phone, the QR Code provided at the Roku Noryo Tea Edition Gin packaging.
 - Scanning the QR Code will take the Participants to the Lucky Draw Website where the Participants are required to submit their lucky draw entry within the Lucky Draw Period by providing their personal details like full name, e-mail address, phone number, and upload their purchase receipt through the “Submit Entry” link present on the Lucky Draw Website.
 - Purchase of one (1) bottle of Roku Noryo Tea Edition Gin will give the Participant one (1) chance to win the Lucky Draw and purchase of two (2) bottles of Roku Noryo Tea Edition Gin will give the Participant three (3) chances to win the Lucky Draw.
 - Depending on the purchase receipt, relevant number of chances to win the Lucky Draw will be recorded by e-lucky draw system which will be used to draw the Winners, as provided hereunder.
8. Incomplete or indecipherable entries will be deemed invalid.

9. Each Participant can participate unlimited times by completing the steps mentioned hereinabove. Each qualifying receipt can only be submitted once for entry into the Lucky Draw.
10. On 6th August 2026, at 2pm SGT at Promoter's office, the Promoter via e-lucky draw system will randomly draw three (3) Lucky Draw entries submitted on Lucky Draw Website in the presence of a scrutineer.
11. On 12th August 2026, the Promoter will announce three (3) winners ("**Winners**") on Lucky Draw Website and also notify them via email.
12. Each Winner is only entitled to one (1) prize.
13. This is a game of chance and skill plays no part in determining the Winners.
14. The Winners will each receive a pair of return economy class flight tickets from Singapore to Japan with a maximum value of SGD 2000 per pair, inclusive of applicable taxes ("**Prize**"). The total maximum value of Prize for Winners shall amount to SGD 6000. Due to factors beyond the Promoter's control, including but not limited to geopolitical conditions, fuel price fluctuations, airline pricing changes, currency fluctuations, or travel demand, actual airfare at the time of booking may vary. In the event that the total cost of the selected flight tickets exceeds SGD 2,000 per pair, the Winner shall be solely responsible for paying any amount in excess of SGD 2,000 directly to the Promoter's appointed travel agency. The Promoter shall not be liable for any such additional costs, nor for any changes, delays, cancellations arising from travel restrictions, governmental advisories or force majeure events.
15. Promoter's travel agency, WORLDWIDE M.I.C.E will contact the Winners to book their return flights for the fly-out period starting from 1st September 2026 till 31st March 2027. If for any reason a Winner does not claim the Prize within 14 working days (before or on 31st August 2026) starting from 12th August 2026, both dates included, then the Prize will be forfeited.
16. The Promoter's decision shall be final and no correspondence will be entered into related to their decision.
17. If any Prize becomes unavailable, the Promoter, in its sole discretion, reserves the right to substitute the Prize with a prize of equal value and/or specification.
18. If there is a dispute as to the identity of a Participant, the Promoter reserves the right, in its sole discretion, to determine the identity of the Participant.
19. The Promoter reserves the right, at any time, to verify the validity of entries and Participants (including the Participant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Lucky Draw. Errors and omissions may be accepted at the Promoter's discretion.

20. Failure or delay by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an individual are reserved.
21. The Promoter also reserves the right to amend, modify these Terms and Conditions, at any time, at its sole discretion, without prior written notice to the Participants.
22. Any costs associated with accessing the Lucky Draw Website is the Participant's responsibility and is dependent on the Internet service provider used. There are no additional costs charged by the Promoter to enter the Lucky Draw.
23. Prizes are non-transferable, non-negotiable and non-exchangeable and cannot be taken as cash, unless otherwise indicated by the Promoter.
24. The Promoter encourages consumers to enjoy responsibly and in accordance with law.
25. As a condition of entering this Lucky Draw, each Participant grants the Promoter, its affiliates and associated third parties a right to publish their names as the Winners for marketing or publicity purposes, in any media, without compensation, restriction on use, attribution or liability.
26. If this Lucky Draw is interfered with in any way or is not capable of being conducted as anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to pandemic, technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any Participant; or (b) to modify, suspend, terminate or cancel the Lucky Draw, either in whole or in part, as appropriate.
27. Except for any liability that cannot by law be excluded, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by the winner or entrant; or (f) taking of a prize.
28. The Promoter collects personal information ("PI") in accordance with Personal Data Protection Act (PDPA) in order to conduct the Lucky Draw and may, for this purpose only, disclose such PI to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to the authorities. Entry is conditional on providing this PI. The Promoter will also use and handle PI as set out in its Privacy Policy, which can be viewed at <https://www.suntoryglobalspirits.com/privacy-policy> . In addition to any use that may be outlined in the Promoter's Privacy Policy, the Promoter may, unless otherwise advised, use the PI for Lucky Draw, marketing, publicity and profiling purposes, including sending electronic messages or telephoning the entrant. The Privacy Policy

also contains information about how entrants may opt out, access, update or correct their PI.

29. All personal data collected from entrants in connection with the Promotion shall be retained by the vendor until 1 October 2026, unless otherwise required by applicable law. Upon the expiration of the applicable retention period, the vendor shall irrevocably purge, destroy, or fully anonymise such data in a secure manner, in accordance with all applicable data protection, privacy, and regulatory requirements.
30. These Terms and Conditions shall be governed by the laws of Singapore.
